From the **MAYOR'S DESK** **Drainage in Sherwood**

Like many other cities, Sherwood faces significant drainage issues. The city's development largely resulted from annexing unincorporated areas, which often lacked proper development standards and engineering. Consequently, floodplain and floodway areas were built upon when they shouldn't have been, and essential drainage infrastructure was typically not integrated into the road systems. Retrofitting these problems is not only cost-prohibitive but often impossible.

Flash floods, caused by rapid and intense bursts of rainfall, can overwhelm drainage systems and lead to dangerous and damaging conditions. Sherwood, with its mix of rugged hills and flat areas sloping into swamps, faces unique flooding challenges that defy a one-size-fits-all solution. In flat floodplain areas, for instance, there is often little the city can do to prevent flooding, especially during a flash flood scenario.

Sometimes, the problem stems from failing infrastructure. For instance, on Brockington Road between Kiehl and Warden Road, collapsed pipes cause water to back up in ditches and overtop the road, an issue that will be resolved with the upcoming road widening project. Similarly, the Laramie project and Sherwood Acres suffer from collapsed pipes, with Sherwood Acres awaiting the outcome of a grant application submitted earlier this year. Although delays can be frustrating, securing substantial funding is a prudent approach. We are actively working to obtain this funding, which should give residents hope for the future.

Flooding can also occur when streams or ditches become obstructed. The city's Public Works department works proactively to clear these areas,

demonstrating our commitment to managing these issues. However, this is limited to dry periods due to equipment constraints. Clearing storm drains is a year-round challenge, often only identified when residents report problems. Unfortunately, some issues are caused by residents themselves. Residents whose homes back up to ditches and creeks should refrain from discarding branches, leaves, and grass in drainage easements, as this debris ends up downstream, causing problems for others. Tracy Sims, Emergency Management and Environmental Compliance Specialist, monitors this situation closely, issuing warnings first or later, issuing citations if the problem is not rectified. This is in accordance with Ordinance 1770, passed in 2008.

Everyone can contribute to improving Sherwood's drainage situation. Keeping storm drains clear of debris such as grass clippings and leaves is crucial, as this debris clogs the drainage system and reduces the capacity of drainage basins to hold stormwater. In the fall, keep leaves out of the street, curb and gutter and roadside ditches; in the summer, bag grass clippings and ensure lawn care companies do not blow grass into the street, which is also hazardous for motorcycles.

Littering exacerbates drainage problems by contributing to clogged drainage basins. It is crucial not to throw trash in pick-up trucks, as it often flies out and creates a nuisance. The accumulation of debris and trash is evident at City Hall's Pond, where grass,

leaves, and trash contributes to water overtopping Kiehl Avenue and other areas, increasing cleanup costs. Residents can report dumping or other stormwater issues to Tracy Sims at 501-835-4753, ext. 1031, or through the city's website, www.cityofsherwood.net. It's important that we all take pride in our community and do the right thing.

Because of the 2023 tornado (which received a presidential disaster declaration), the city now qualifies for SWIFT grants through FEMA and the Arkansas Department of Agriculture. To be eligible for assistance under this program, you must have verifiable flood damage to your home of \$1,000 or more at least twice within ten years. You also must have had continuous flood insurance on the home through the National Flood Insurance program. This program is typically a 75/25 program for the cost of the project. The options usually include buyout/demolition, elevation of property, or floodproofing. Tracy is currently working with several homeowners who qualify and want to participate in this program. Contact Tracy, if you feel you are a candidate and would like more information. The city will assist you with the paperwork and be your necessary sponsor. However, the results are not our decision. A committee meets to review each individual application and decides eligibility on a state and federal level.

A recent statement at the Council Meeting incorrectly suggested that park funding detracts from drainage projects. Park funds come from a separate budget — A&P monies, which by state law cannot be used for drainage problems. Drainage projects are funded through the Street Fund Budget.

With weather patterns becoming more intense, flooding will always present problems. We all need to do our part to ensure that our actions do not make flooding worse. In summary, residents can help mitigate drainage issues in Sherwood by:

- Keeping storm drains clear of debris like grass clippings and leaves.
- Properly disposing of yard waste instead of discarding it in drainage easements.
- Avoiding littering, which clogs drainage basins.
- Reporting dumping or drainage problems to Tracy Sims at 501-835-4753, ext. 1031, or via the city's website, www.cityofsherwood.net.

Let's ALL be part of the solution, not part of the problem! Remember, the city is committed to addressing these drainage issues, and your cooperation and support are crucial in this endeavor.

SUMMARY REPORT

JULY 22, 2024

CITY COUNCIL MEETING



PASSED - A resolution authorizing a grant application to the Arkansas Department of Parks, Heritage, and Tourism for improvements to Duran Park.

PASSED/AMENDED - An ordinance amending the existing zoning code with respect to conditional use permits and for other purposes. This was read one time at the June meeting. This revision is meant to improve transparency, process, and accountability to safeguard the public and applicants. By providing more clarity on the process, the changes will help ensure the provisions are more equally applied over time.

PASSED - A resolution approving the purchase of certain real property in conjunction with the Jacksonville-Cato Road project.

PASSED - A resolution designating and authorizing the mayor to execute certain documents in connection with funding administered by the Arkansas Natural Resources Commission for wastewater improvements on the interceptor lines in the southern area of Sherwood.

SECOND READING OF - An ordinance amending Ordinance 2140 regarding the adoption of new policies and procedures for animal control. The purpose of this ordinance is to update the policies to reflect current best practices in this field. One of the many updates is changing the breed-specific language to that of behavior. A dog would be labeled vicious based on behavior versus breed. There are strong opinions on both sides of this issue, and there has been a lot of public comment. Read one time at the June meeting and will be read again at the August meeting, at which time the vote will take place.

PASSED/AMENDED - An ordinance approving a 4% pay increase for certified police officers. The purpose of this is to make Sherwood more competitive in the recruitment of police officers and bring the pay in line with other cities in Pulaski County.

READ ONE TIME - An ordinance assessing a 1.0 mill tax on real and personal property as a new millage certifying to the Pulaski County Clerk the new millage and the existing 1.3 millage to be levied by the City of Sherwood on the taxable real and personal property for the tax year 2024. The purpose of this is to increase revenue to offset the rising costs of public safety. The second reading will be at the August meeting.

New Business - Sherwood Court document destruction date - August 2 @ 8 AM.

Tom Brooks gave an update on Act4Sherwood.

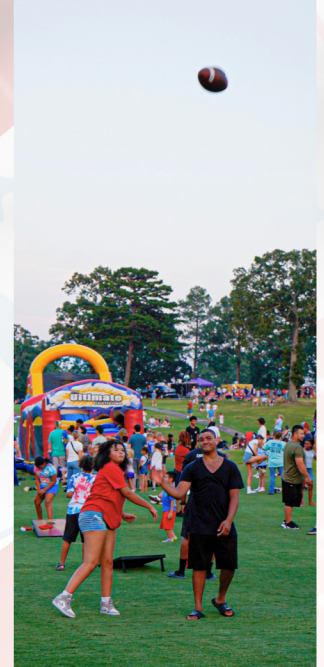

Husband and Wife Elected to Lead the State's Largest Veteran's Organization

A historic event has occurred within the American Legion Department in Arkansas: a husband-and-wife duo has been elected to lead the state's largest veteran's organization. Antoine "Tony" Gordon and his wife, Pearl were elected during the 105th American Legion Arkansas State Convention in June. Antoine will serve as the state commander of the American Legion, while Pearl will serve as the state president of the American Legion Auxiliary. This marks only the third time in the organization's history that a husband-wife team has held these positions.

The Gordons describe their roles with a simple yet profound motivation: a heart for serving. "We enjoy doing that, and if anyone has a heart for serving, then this may be an organization for you," says Pearl. Many veteran groups have praised Tony and Pearl for their leadership, finding inspiration in their united approach. "That's what makes it special, to see people tell us how inspiring it is to see us doing this as a family," says Tony.

Combining their experiences, Pearl and Tony have significantly impacted many veterans and their families. Tony shares a touching memory of helping a veteran receive mental health care, a gesture that the veteran credited with saving his life. "I walked him over to the mental health clinic at the hospital and sat down and waited for him to receive treatment. Soon after that, he received compensation for the service connection. That, in turn, turned his life around. Now he's a member of the American Legion," Tony recalls.

The Gordons emphasize the importance of community in their organization. "Our membership is our greatest asset. Without the members, we cannot work the mission," says Pearl. They encourage anyone with a servant's heart who enjoys donating, working with veterans, or engaging with the community to contact the American Legion Auxiliary.

On June 27, the American Legion Post 74 held a reception honoring the Gordons at the Jack Evans Senior Center in Sherwood. The post holds its monthly general post meetings on the first Saturday at 9:00 am at the same location. The Gordons, who live in Jacksonville, celebrated their 39th wedding anniversary in July. They also have two children.
